**Call for abstracts is open** for papers and poster presentations from all disciplines of healthcare. Submissions should reflect the conference theme of 'ENs Matter' in the areas of, but not limited to;

- *Innovative clinical practice* - new models of care, innovative practice, telehealth, collaborative, multidisciplinary, rural & remote, CALD, NDIS, Aged Care
- *Education and Professional Development* – continuing education, career pathways, mentorship, and leadership.
- *Wellbeing & self-care* – harmonious collaboration, interpersonal communication, psychological safety, financial security, cultural & social, diversity & inclusion

**Presentation Types:**

1. Oral presentations: 20 minute presentation, including 5 minute question time.
2. Poster presentation: displayed during the conference with allocated opportunity to answer queries during breaks from oral presentations.

**Abstract submissions: Author instructions.**

- Microsoft word version, A4 paper size. Embedded template below.
- A fifty word biography for each presenting author.
- The abstract title should be short (strictly no more than 12 words), informative and contain the major key words. It should be in Arial, BOLD, 14 pt size, and centre aligned. The abstract title should be in initial capital/lower case, not all capitals.
- Arial font, single spacing, right, and left justified for body of text.
- Maximum of three hundred [300] words.
- Abstract Titles should be followed by authors' first initial then surname (with the presenting author/s in bold). These should be in Title Case, Arial, 12 pt size, and left aligned. Superscript numbers must be used to indicate the author's institution or organisation, followed by city and state (in this order). Do not include degrees or professional titles (e.g. Dr, Prof., etc) or post nominals.

**Abstract text**

- Abstract text must be in Arial, 12pt size, single-spaced and justified.
- Sub-headings e.g. Introduction, Method, Results etc may be included if required, however they will be included in the word count.
- Abstracts are to be a maximum of 300 words, including references.
- There is to be a maximum of 2 references. References should be listed at the bottom of the page, in Sentence case, Arial, 10 pt size and justified. Please do not use footnotes or superscript numbers within the body of your abstract.
- Use standard abbreviations only. Within the body of the abstract, when using abbreviations spell out the name in full at the first mention and follow with the abbreviation in parenthesis. Abbreviations may be used in the title, provided the name in full is outlined in the body of the abstract.
- Capitalise the first letter of trade names.
- Do not include images, graphs, tables etc. Text only.

**How to submit your Abstract:**

Abstract submission will only be accepted via email to [enpasecretary@gmail.com](mailto:enpasecretary@gmail.com) and must include the following:

- Your abstract, prepared in Microsoft Word A4 document, adhering to the formatting guidelines listed above.
- Your brief biography (50 words or less).
- Include your name, position, organisation, and brief biography of any co-authors.

- Please note - the main presenting author to submit the abstract & provide email for correspondence. All authors names will appear in the program. **CALL FOR ABSTRACTS CLOSES 5pm 4th of July 2025**
